## Job Summary:

Veterinary Coordinator (VC) assists HoO in implementation of Neutering Programme through regular and virtual visits and meetings with local partner veterinary clinics to ensure that relevant local laws as well as DT SOPs and contracts are strictly adhered to.

VC's proactive involvement increases the operational efficiency and improves the effects of Neutering Programme, while decreasing risks.

## Main duties:

- Implement virtual supervision of surgical neutering procedures and supervisory visits to the clinics to ensure the local laws as well as DT SOPs and contracts are strictly adhered to and any risks are eliminated
- Ensure all video and hard copy documentation is submitted by the clinics, reviewed for accuracy and filed appropriately in a timely manner
- Ensure the clinics' invoices are double checked for accuracy
- Participate in VTP Programme courses in a supervisory capacity
- Ensure all Programmes run by Department are aligned with currently relevant local laws
- Other tasks as needed
